1.0 PURPOSE OF REPORT

1.1 The Combined Authority is required to appoint a Head of Internal Audit in order to comply with its internal audit obligations contained in the Accounts and Audit Regulations 2015.

2.0 BACKGROUND

- 2.1 At the meeting of the Combined Authority which took place on 18 March 2024, Members resolved that Officers could appoint a Head of Internal Audit. The Interim Head of Paid Service has agreed to make this decision.
- 2.2 The Combined Authority have appointed Veritau as their Internal Auditors and the Office of the Police, fire and Crime Commissioner and the North Yorkshire Fire and Rescue Service, who are transitioning into the Combined authority on 7 May 2024 have appointed RSM as their Internal Auditors.
- 2.3 The Internal Auditors are agreeable in principle to Veritau being appointed the Head of Internal Audit for the Combined Authority as a whole, this appointment being a legislative requirement.
